Through the Hockey Helmet Program, local arenas can order affordable, CSA approved hockey helmets to provide children with proper protective gear for public skating and school skates.

## The Need

Among people under age 20 in Canada, there are more deaths from injury *than from all other causes combined*. Head injuries are among the most serious of all childhood injuries. Children should have proper skating-specific headgear to prevent serious head injuries.

Some NS regional school boards have now made CSA hockey helmets mandatory for all children participating in school-sponsored skates. The new policy impacted a number of schools and arenas as the school-sponsored skates were cut back or cancelled.

The Hockey Helmet Program will ensure that participating local arenas can provide children with the proper headgear they need to take part in school sponsored skates and free skates, helping kids stay active and stay safe.

## The Program

Participating groups can purchase CSA hockey helmets for **only \$10.00** each to a maximum of 20 helmets. This program is making it truly affordable for arenas to provide children with proper protection. Please complete the attached application form and fax or mail to the RFANS office. There are only a limited number of helmets available.

RFANS and the Department of Health and Wellness will from time to time follow-up with those who participate in the Helmet Program. Information such as frequency of use, increased participation and data such as this will help to determine whether the program has been a success and should be continued or expanded. Your assistance with this data collection would be greatly appreciated.
