## Trade Show Rules & Regulations

### Contract & Liability

The Atlantic Recreation and Facilities Conference and Trade Show Planning Committee is not liable for any damages whether direct, indirect, general, special, consequential or otherwise to the exhibitor, its agent and employers or visitors to its exhibits. The Committee is not responsible for any lost, damaged or stolen property.

### Space Assignment

Booth spaces will be assigned at the discretion of the Exhibits Committee. The committee will attempt to honor the exhibitor's request; however, space placement cannot be guaranteed. The committee reserves the right to assign the exhibitor to an alternative space. Assignment of space will be considered in the order in which contracts are received.

### Protection of Building Property

Nothing shall be pasted on, tacked, nailed, screwed or otherwise attached to columns, walls, floors, or other parts of the building or furniture. Exhibitors violating this regulation are expressly bound, at their expense, to repair such damage which they may cause.

### Exhibitors

By signing the Trade Show Registration form, the signer agrees to:

- 1) Maintain your exhibit in a professional manner
- 2) Have your exhibit setup by 4:00pm and removed by 10:00pm on Wednesday, May 30<sup>th</sup>, 2018

### Refund Policy

Cancellation up to and including April 25, 2018, a \$50 administration fee will be charged. No refunds will be issued after April 25, 2018, if space is not filled. Cancellation after April 25, 2018, 50% refund if space is filled.

## Regulation Enforcement

The Atlantic Recreation Conference and Trade Show organizers shall have full power in the interpretation and enforcement of the violation of proper conduct of an exhibit and all connected personal items. Such decisions shall be binding upon all exhibitors. Failure by exhibitors to comply with these or any other regulations or amendment may be sufficient cause for the committee to require immediate removal of the exhibit from the offending exhibitor, who forfeits all further rights at the trade show and all the fees and rentals paid. The Committee shall reserve the right to reject any or all applications.
